Summary/Objective of the project	<p>Gujarat state has 3 prohibition acts with 80 permit types limiting users to consume liquors in a state. Basic idea is visitor needs to visit eps.gpeonline.co.in portal to apply for the permit required. He needs to select relevant permit category than needs to create an account, where email and mobile verification compulsory for Indian resident. He can now upload required documents with details and can apply for the permit for selected dates by him/her. He has pay online fees if applicable via which he will get a permit with security code to avoid duplication. After physical approval he/she can get defined quota from authorised license shops. Realizing that the prohibition laws were becoming a deterrent, the new rule allows tourists landing in Gujarat to get their drinking permits at the time of arrival at airport itself. Now, tourists can get necessary forms and file it along with the permit fee at the airport itself with officials of Department Of Prohibition & Excise - GoG (DPE). Main objectives of DPE are as follows: Tourist/Visitor/Group/Health can apply online permit with their proof documents Reduce the human interference in the process and make it transparent.</p> <p>Visitors, Tourists (Foreigners), Health Permit Holder, Special Permit Holders, Department of prohibition & excise staff, License holders (Hoteliers)</p>
